From The Director



It has been a busy few weeks, so I thought I would share some highlights and reminders:

Advocacy Day – Next week is the final week to sign up for our transportation to Advocacy Day on Wednesday, February 27. We currently only have 30 people signed up and would love to have a stronger showing of support in Albany. Advocacy Day is for everyone – trustees, library staff, Friends groups, and patrons. We currently are in need of people from Antonocci's

district, Manktelow's district, and Akshar's district. Please consider signing up today to join us for this important advocacy effort at www.flls.org/calendar-2/.

DAC Meeting – Our Directors' Advisory Council met at the end of January to discuss a variety of topics. Our DAC group is made up of directors from our 3 largest libraries (TCPL, Auburn, and Cortland), and then two directors from each of our five counties. We discussed advocacy efforts, NYLA's legislative talking points, the 2020 Census and planning for library needs for this important project, reviewed a billing policy for FLLS, and formed an e-content committee to evaluate our e-content needs as a system. The committee will next meet on April 24.

County Meetings – I attended the Seneca County libraries meeting on February 1 in Interlaken. We discussed county advocacy efforts and referendum plans for the five libraries. Nora and I attended the Cayuga County libraries meeting in Auburn on February 6. Those libraries also discussed county funding and advocacy efforts, as well as having a discussion about e-content needs, system training and workshop needs, and a review of the DAC meeting.

Annual Reports – A reminder that libraries will need to submit their annual reports to us for review by next week. If you are holding a board meeting after next week to approve your reports, please notify both me and Kristi so we can work with you about when you can submit your report. The State deadline for us to submit all reports is March 1. Failure to submit on time results in us having our funding put on hold, so it is vital we submit by this deadline. A member library failing to submit by the deadline means that services will be revoked until completion, such as delivery, Polaris access, ILL access and more. We never want this to occur, so please complete your reports on time.

State Construction Needs Assessment – System directors were notified this week that the State will be looking for information from all public libraries about project construction needs in the coming weeks. The time period they will be looking for is projected construction needs for 2020-2025. This information is key for construction grant advocacy and library advocacy in general, so please start thinking of your needs. As soon as we get the survey information, we will be sending it out by email. The turn-around time for answers is usually fast, so I wanted to notify you now so you can start your projections.

Ithaca Voice:

Tompkins County Public Library goes fine free

ITHACA, N.Y. — The Tompkins County Public Library is now a fine-free library.

As a way to make sure people truly have free access to books, TCPL has done away with fines on late items. The initiative quietly rolled out Jan. 14.

"What it really is is a movement," Library Director Annette Birdsall said. "It's libraries recognizing that this is a social equity issue, that fines have become a privilege and they — not only do they not work — they actually encourage people to keep materials longer if they can afford it. If you can afford it, you pay your fines, you don't feel guilty and you support the library. We love people to support the library. We don't love that it was a privilege and that people who couldn't afford fines stopped using the library altogether."

Birdsall said though fines were in place to encourage the return of materials, they became a barrier to access. She also said the library recognizes that people want to return books, but there are sometimes challenges to doing that on time. And when the fines begin to add up, sometimes people are embarrassed and don't want to use the library because they can't afford to. **CONTINUE READING...**

Scam Alert!

Q4 2018 Top-Clicked Phishing

Email Subjects From KnowBe4

KnowBe4 reports every quarter on the top-clicked phishing emails. Here we have the results for Q4 2018. We track three different categories: general email subjects, those related to social media and 'in the wild' attacks. The results come from a combination of the simulated phishing emails used by our customers as well as from the millions of users that click our no-charge Phish Alert Button to report suspicious emails to their IT Incident Response team.

Trends That Persisted Throughout 2018

In reviewing the Q4 2018 most clicked subject lines, trends were easily identified; five subject line categories appeared quarter-over-quarter throughout 2018, including:

- Deliveries
- Passwords
- Company Policies
- Vacation
- IT Department (in-the-wild)

Additionally, three "in-the-wild subject lines" were clicked three out of four quarters and included Amazon, Wells Fargo and Microsoft as keywords.

The Subject Lines Tell Us Users Are Concerned About Security

"Clicking an email is as much about human psychology as it is about accomplishing a task," said Perry Carpenter, chief evangelist and strategy officer at KnowBe4. "The fact that we saw 'password' subject lines clicked four out of four quarters shows us that users are concerned about security.

Likewise, users clicked on messages about company policies and deliveries each quarter showing a general curiosity about issues that matter to them. Knowing this information gives corporate IT departments tangible data to share with their users and to help them understand how to think before they click."


Make Your Mark: Logo Design for Librarians Thursday, February 28, 2:00pm

Blind and low-vision teens who are ready to learn new things, meet new people, and have an adventure this summer are encouraged to apply.
