From The Director



This week saw disappointing news for libraries in the NY State 2019 – 2020 Budget. When Governor Cuomo first released his proposed budget in January, it marked his ninth consecutive budget in which he proposed to defund the State Library Aid program. While his proposed \$5 million cut in library aid was restored, we did not gain the additional \$1 million the Senate had suggested adding. Library aid remains the same as last year. This is in essence a cut to the Finger Lakes Library System, as contractual prices for databases, e-content services, and health insurance continue to increase every year.

The most devastating cut in this year's budget is the library construction aid. After gaining \$20 million last year and helping us with vital library expansions and renovations, this money was lost and library construction aid reverted to \$14 million. After the budget was released this week, we polled our libraries quickly and already have been alerted to library expansion projects, bathroom upgrades, and a possible new building for one of our libraries.

One hopeful aspect of the budget for libraries is \$15 million in targeted aid. While we don't know what exactly this will look like, it appears to be similar to Bullet Aid. However, this targeted aid to school districts, public libraries, and not-for-profit institutions will be divided equally between the Senate, Assembly, and the Governor. As soon as FLLS receives more information, we will be sending out information on how to apply for this aid.

It is not just NY State libraries we have to worry about. On a national level, advocacy efforts are also needed. The American Library Association is asking Senators to preserve more than \$210 million in federal funding for libraries. The Senate deadline is April 5, so now is the time to let your Senators know how important libraries are to their constituents and the entire State. Our State Library in Albany receives federal money, and a cut in their funding will impact state library services. Kristi sent out an advocacy alert email on Thursday with more information if you are interested.

Jenny sent out Census information last week to provide our libraries with historic Census data information and a timeline for the 2020 Census. Please expect more Census information from us shortly. The State Budget does include \$20 million for the 2020 Census, with libraries expected to receive a portion of that money.

Scam Alert!

Emerging Threats: 6 Spam, Phishing and Malicious Email Trends to Watch For

Cybercriminals aren't going to exert more effort than they have to. For all the talk of the sophisticated investment required to discover and exploit vulnerabilities to obtain a foothold into a targeted environment, email remains a perfectly welcoming – and far more time- and cost-effective – medium. The payoff is simply too good for cybercriminals. Of course, that doesn't mean attackers aren't shifting tactics or developing innovative ways to take advantage of this low-hanging fruit and stay one step ahead of the defenders. As always, knowledge is power when it comes to combatting the latest cyberthreats. Here is what Trustwave SpiderLabs incident investigators are seeing in the world of email.

Sextortion Messages: There is a rise in email-based blackmail, in which malicious senders attempt to trick users into believing that an attacker has obtained embarrassing information about them visiting pornographic websites and has collected pictures and audio from a hacked webcam. The sender threatens to release the allegedly compromising content to everyone in the victim's contact/friend list or upload to their social media profile unless a payment is made (usually in cryptocurrency). For additional reading on this particularly terrifying threat, our Fahim Abbasi covered produced two blog posts.

IoT Botnets Delivering Spam: A collection of compromised IoT devices can form a formidable botnet (as was evident when Mirai arrived on the scene in late 2016) and the susceptibility and sheer growth of connected smart devices is providing a conducive pathway for more to emerge. Most of the action we have observed has been because of home routers, which failed to undergo proper patching as these devices rarely receive any kind of support after their release. Many of 2018's biggest botnets used 5- or even 8-year-old vulnerabilities in router/modem firmware. These include Pitou, Type52 and Xinbot

A New Host Nation: Brazil has risen as a new source of phishing and banking attacks. Campaigns from this country were mainly targeting Latin American financial institutions, but customers from other regions, predominantly North America and EMEA, were affected as well.

File Extensions: As more users are trained to recognize tell-tale signs of phishing and spam, such as misspellings, grammatical errors and language issues, well-crafted messages greatly increase attack success rates, as do the usage of popular file types, a common way for malicious actors to mimic third-party communication and avoid detection by traditional email security. Most attachments used in malicious email files continue to be file formats related to message visual aspects (.gif .js) and MS Office documents (.xls and .doc) with malicious macros.

Emotet: This banking Trojan obtains financial information by injecting computer code into the networking stack of an infected computer, allowing sensitive data to be stolen via transmission. Emotet is often concealed in documents delivered through emails that pretend to be from financial institutions. The emails came with a Word document embedded with malicious macro code. Once executed, the code downloads and runs Emotet. The malware is not the final payload, though, as it acts as a downloader for additional malicious code.

Supply Chains: Attackers are increasingly use the supply chain in their email evil-doing, utilizing legitimate business partners – which are the victim of an initial attack – to distribute phishing/spam emails by using compromised legitimate addresses. Most of these third-party companies are unaware that they were spreading malware to all their business contacts. This approach increases ingress success rates for attackers by adding a “trusted” source of communication.

Polaris FAQ

Deleting Items Properly

Batch Deletion of Items Records: The most efficient method of deleting multiple Item Records in Polaris is by using Record Sets.

1. First, create a new Record Set: File → New → Record Set → Item. Name your Record Set (please follow the established naming convention). Select the Scan by Barcode icon and scan the barcode of the periodical you wish to delete into the Record Set. Save the Record Set.
2. Once the items are in a record set, it's simple and painless to delete the records using the Deleted Selected Records button located in the middle toolbar. Note: Items that have a status of "Checked Out" cannot be deleted.
3. Selecting all the records first allows you to delete them all at once. Press CTRL+Shift+A on your keyboard to retrieve all the records then press CTRL+A to highlight all records.






3. The Multiple Object Deletion Dialog Box will pop up. Uncheck the 2 checkboxes which will prevent any dialog boxes from popping up during the deletion process.



4. Once the Items are deleted, you will see another Dialog Box prompting you to delete the Bibliographic Records that no longer have any Items attached. Note: This must be done because we don't want Bibliographic Records without items to display in the catalog.



5. Once the empty bibs are deleted, you will see another Dialog Box prompting you to delete the unlinked Authority Records. Note: This must be done because we don't want Unlinked Authority Records in the catalog.



6. Any records left in the Record Set could not be deleted. It could be that the Item Circulation Status is Out or there is a Hold Request linked to the Item. Try deleting each item individually without unchecking the 2 checkboxes to find out why. If there is a Hold Request associated then you will need to cancel the Request before the Item can be deleted. Awards, Contests, & Grants

Friends of the Tompkins County Public Library Education Grants

Deadline: April 17

The Friends is offering local librarians, library assistants, and future librarians grants to continue their professional education. These grants are available to staff members of libraries (including school libraries) within Tompkins County to partially cover costs of attending professional meetings, workshops, training sessions, and conferences, and to defray the cost of course work. You and your staff members are eligible to apply for such funding.

Awards amounts are typically in the several hundreds of dollars. The applicant must provide information about the content of the proposed program, associated costs, and any other available financial support, as well as two letters of recommendation, one from a supervisor.

Completed applications should be submitted electronically to edgrants@booksale.org by April 17, 2019. Grant recipients will be informed by April 30, 2019.

ARSL Scholarships

Deadline: May 24

Criteria for these scholarships has changed slightly so be sure to read and apply for the one(s) that fit you!

These scholarships are for first time attendees so anyone who has **NOT** previously attended an ARSL conference is invited to apply.

This year, four scholarships will be awarded by ARSL. The Dr. Bernard Vavrek scholarship is for current library school students. The Founders scholarship is for current ARSL members who have been working in in the library profession for 5 years or less. The Ken Davenport Scholarship is for current ARSL members who have been working in the library profession for 6 to 10 years, and the Angel scholarship is open to current ARSL members who have been working in the library profession for any length of time.

Applications must be submitted by 5pm Central Time (6pm EST) on May 24, 2019 to be considered.
