- A school ballot vote (or votes) was held in FY 2013, including failed votes
- School ballot funding approved in a previous year was still in effect in 2013

2.13 Electronic Books, 2.20 Audio-Downloadable Titles, 2.21 Video-Downloadable titles

- These new sections are for Overdrive titles, plus any <u>downloadable</u> titles that you offer locally, in addition to Overdrive. Everyone should count the entire Overdrive holdings as their own, as they are available systemwide.
- Question 2.13 = 15,933 Overdrive titles
- Question 2.20 = 2,317 Overdrive titles
- Do NOT count titles loaded onto eReader devices or Tumblebooks.
- If you are counting an additional local service:
 - o If a title is licensed to allow 100 simultaneous checkouts, count it 100 times.
 - Downloadable items checked out as one unit count as "1"

3.53, 3.54, 3.55 Digital Literacy

4.10 Circulation of Electronic Materials

This question is new in 2013, and is for reporting materials transmitted digitally, such as Overdrive titles. Please consult the *Running Reports Guide* for more information.

4.15 Does the library offer virtual reference?

This question is new in 2013. Everyone should answer Y for yes as AskUs 24/7 is available systemwide.

9.12 School District

New question, answer the school district the library is located in.

9.31 Number of wireless access uses per year.

New question this year. If you do not have this tracking capability, please answer "0" and add a state note explaining that you do offer wireless access, but have no mechanism to track the number of uses.

If you tracked uses for part of 2013, use this data to estimate the yearly average.
