# **From The Director**



As we come to the end of 2019, I would like to use this opportunity to thank our library directors, staff, trustees, and volunteers for helping our libraries grow and succeed. Here are some highlights over the past year and a preview of 2020:

**Fine Free Libraries** – Many of our libraries, including the Tompkins County Public library and all five libraries in Seneca County, are now fine free. Over the past few years, going fine free has been a national trend in public libraries, with consistently positive results for their communities. Late fees discourage people who cannot afford to pay them from using our libraries, and we want equitable access to all of our library services, collections and programs. If your library wants advice on how to go fine free, please contact Sarah or Nora for more information. We are more than happy to come and speak to library boards.

**School Ballot Referendums** – 57% of our member libraries took part in school ballot referendum votes this year and all 19 votes were successful. One of our member libraries in now completely funded by school ballot referendum funds, eliminating the need for village, town, or county funding. We began working on 2020 referendums immediately after the May vote and anticipate many of our libraries being on the ballot again in 2020. If your library would like help with organizing a referendum vote, marketing, or advocacy advice, please contact Sarah or Nora. We want all of our libraries to receive the funding they deserve.

**New York State** – Slow growth in New York State funding of libraries is impacting the Finger Lakes Library System. The longer flat or just slight increases in State funding occurs, the less we are able to offer our members. FLLS is being used differently by our members over the past five years, with an increased need of consulting, HR help, mediation, and continuing education. Both PULISDO and NYALS are looking at different advocacy approaches to improve our messaging to the State. This summer, Lauren Moore was appointed as the new State Librarian, and both groups have met with Lauren to discuss our concerns.

**2020 Projects** – We have many large projects in the works for 2020 both at the system level and with our member libraries. FLLS is actively preparing our members for the 2020 Census, which will be the first Census that includes a digital response option. We are also preparing our member libraries for updated NY State minimum standards that will be in place on January 1, 2021. FLLS will be holding more trustee training opportunities to prepare for possible legislation that would require public library trustees to complete 2 hours of trustee training annually. We also will be starting focus groups and planning for our next five year plan of service, which is due in 2021 to NY State. At a system level, we are preparing for a catalog clean-up project during the first part of 2020.

I wish everyone a very happy holiday season and a wonderful new year!

# Scam Alert!



## Iran Has Launched Evil New Malware That Wipes Your Windows Workstations

IBM warns that Iran's state-sponsored hackers have deployed a new strain of malicious wiper malware, which has been aimed at the "industrial and energy sectors" in the Middle East but you can expect that to expand worldwide.

No specific companies have been identified, but there's no surprise in the nature of the attack. For Iran, its ongoing hybrid conflict with the U.S. and its allies has made these sectors a target. IBM has attributed the latest "destructive attacks" to Iran's hyperactive APT34 "and at least one other group, [also] likely based out of Iran."

APT34 has hit the headlines a few times this year, including with a phishing attack using LinkedIn. But it's the identity of that "one other group" that's arguably more interesting. The sectoral targets and use of wiper malware points towards Iran's APT33, arguably the best known of its threat actors.

This is the group behind the Microsoft Outlook exploit in July, prompting a U.S. government warning, and which deployed its own VPN to veil "aggressive attacks" on U.S. and Middle East targets in the oil and gas sector.

APT33 was also behind the infamous 2012 Shamoon attack on Saudi Aramco, an attack which erased the data on most of the company's 20,000 computers.

### **Census Jobs**

The U.S. Census Bureau is recruiting to fill hundreds of thousands of positions across the country to assist with the 2020 Census count. Hold a Census Job Recruiting Event at your library! Contact Jenny at jshonk@flls.org for details!

### **Job Qualifications**

To be eligible for a 2020 Census job, you must:

- Be at least 18 years old.
- Have a valid Social Security number.
- Be a U.S. citizen.\*
- Have a valid email address.
- Complete an application and answer assessment questions. (Some assessment questions are available in Spanish. However, an English proficiency test may also be required.)
- Be registered with the Selective Service System or have a qualifying exemption, if you are a male born after Dec. 31, 1959.
- Pass a Census-performed criminal background check and a review of criminal records, including fingerprinting.
- Commit to completing training.
- Be available to work flexible hours, which can include days, evenings, and/or weekends.



### Most jobs require employees to:

- Have access to a vehicle and a valid driver's license, unless public transportation is readily available.
- Have access to a computer with internet and an email account (to complete training).

# **Polaris FAQ**



**Add Your Items to the Correct Bibs** 

**Titles with different ISBNs should be on separate records**. Make sure to add your items to the correct bibliographic record! For example, a regular print book and a large type book will have separate ISBN's and therefore separate bibs! If there is only a bib record for a regular print book and you have a large type book, then you would create a QuickBib! **Questions?** Contact Jenny at jshonk@fils.org or Deb at dgeier@fils.org. Check out more information about ISBNs and UPCs below!

A Quick Bib requires an ISBN (MARC tag 020) and/or a UPC/EAN code (MARC tag 024). If no ISBN AND no UPC/EAN code available on the item, **DON'T CREATE** a Quick bib. If by chance, only an ISBN or a UPC/EAN code is available, please enter "none" in one or the other remaining tag. For example:

020 (ISBN)	1400060079
024 (UPC/EAN)	9781400060078

020 (ISBN)	none
024 (UPC/EAN)	9781400060078

020 (ISBN)	1400060079
024 (UPC/EAN)	none

### • DON'T CREATE A QUICK BIB WITH:

020 (ISBN)	none
024 (UPC/EAN)	none

 The ISBN can be either 10 or 13 digits in length. The 13 digit IBSNs begin with 978 or 979 (for example, 9780553803426) – NEVER enter the segmented numbers with hyphens. For example:

YES: 020 (ISBN)	1400060079
NO: 020 (ISBN)	1-4000-6007-9

 The UPC/EAN code may vary in length, usually 11-13 digits – DON'T enter spaces or hyphens. For example:

YES: 024 (UPC/EAN) 9781400060078 NO: 024 (UPC/EAN) 97 8140006007 8

Be very careful transcribing the ISBN and/or UPC code. If there is an error, it
makes it very difficult for FLLS catalogers to replace the Quick bib with a
permanent bib record. Scanning the ISBN/UPC eliminates errors. If your scanner
doesn't scan ISBN's/UPC's, contact Rex and he will help configure your scanner.
