

FROM THE DIRECTOR



As of this past Wednesday, library workers are now eligible for receiving vaccines under the not-for-profit category in NY State. I know of many of library workers in our service area who have been able to receive their shots this week, and I am thankful that public library system staff are also eligible this week. I was able to receive my first shot this morning and am extremely grateful for the opportunity. Here are some other items to note:

NY State Budget – The Senate and the Assembly have released their one-house budget proposals. The Assembly is proposing \$96.6 million in library aid, while the Senate is proposing \$94.1 million in library aid. Both are recommending library construction aid at \$34 million. A reminder that the legislature is currently discussing and debating the final budget, so now is the time to speak up and contact your representatives to ensure they know our needs and increase funding for libraries.

Quarantine Time for Library Materials – During our monthly member library directors' meeting, we discussed how long library materials were being quarantined at individual libraries. In addition to quarantining materials at libraries, FLLS was doing an additional 3 day quarantine at our system. After consulting with our driver and pages, FLLS will be rolling back to a 24 hour quarantine, effective immediately. We will be working on our backlog of items, so please be aware you may see more bags than usual while we get caught up. A reminder that it is up to an individual library on how long you quarantine materials and we encourage you to have discussions with your staff about their comfort level before scaling back quarantine times.

Minimum Standard for Open Hours – The State Library and PULISDO have been working together to look at which libraries are open in the State and what can be done to eliminate barriers to reopening during the pandemic. Each month, public library systems input data on a spreadsheet for the State that includes if a library is open, doing curbside, has access to library stacks, access to computers and more. The February 2021 snapshot data indicates that 74% percent of public and association libraries are currently meeting the minimum standard for open hours. With the COVID-19 vaccine being made available to library workers, the New York State Library/PULISDO Reopening Committee projects that libraries will be able to meet the minimum standard for open hours by June 1, 2021. FLLS has a small number of libraries not currently meeting this standard, and will be working individually with those libraries for them to meet this standard by June 1.

Exactly one year ago, all of our member libraries were closed due to the pandemic. From having to quickly close our buildings to transitioning to e-content services and virtual programming, our libraries immediately adapted in order to continue providing library services to our communities. I would like to thank our library staff, directors, and trustees for all of their hard work and commitment to their libraries over this past year. It's been a year of change, hardship, and confusion, but also a year of resilience, innovation, and dedication. The past year has been the hardest in my 21-year career as a librarian, but it has also taught me a great deal and I'm grateful to share the journey with you.


SCAM ALERT!

Security Alerts!

There have been multiple security bulletins recently on vulnerabilities in several software packages like Adobe products, Google Chrome and Firefox web browsers and of course Microsoft Windows and Office.

Each of these software products should be checked to see if there are updates available. Follow past guidance on performing Windows critical and optional updates on public computers where Deep Freeze is involved.

- For Adobe Acrobat Reader DC and other Adobe products start the product, Click on Help and then on Check for updates.
- In Google Chrome, click on the 3 dots in the upper right corner then on Settings and then on About Chrome which is located at the bottom of the list on the left. Chrome will automatically check for and download any available updates.
- Firefox works similarly. Click on the **menu** (three flat lines) in the upper right corner then on **Help** then on **About**. Firefox will automatically check for and apply any available updates.



Helpdesk Updates from Rex

I have posted 2 new solutions in the FLLS Helpdesk. Click on the image below to visit the Helpdesk.

Something that has been regularly commented on in regards to the Leap Web App is that you have to click on the Print button on Windows Web Print prompt which has added an extra step to the Checkout and Checkin workflow. To help mitigate this, I have found a way to suppress the Windows Print dialog window in the Microsoft Edge browser. Since most libraries use the Google Chrome browser as their default browser for everyday web browsing, the MS Edge browser which is now based on the Google Chromium code base, lends itself as an ideal browser to use as the default for the Polaris Leap Web App.

Setting up a Polaris Leap shortcut to use Microsoft Edge in "Silent Print" mode as your default Polaris Leap browser so you don't have to click on the Print button or press enter to print:

You will need to login to the Helpdesk with your credentials. All member library directors and many library staff already have Helpdesk logins. If you've forgotten your password there is a link to recover/reset your password. If you don't have a login and need one, there is a link in the lower section called "Sign up to submit and track your service requests" where you can request a login. Please try clicking on the Forgot Password before requesting a new Helpdesk login to see if you already have a Login.
