FROM THE DIRECTOR



Here are some updates for you:

NY State Budget – As this newsletter goes out, we still don't have a New York State Budget. Originally due by April 1st, budget talks are still ongoing and not finalized. As we are all aware, our Governor is dealing with legal issues on a personal level and the State is also trying to work with a large influx of federal money. We now expect a finalized budget either over the weekend or early next week.

Even though we are in the final days of having a budget, library advocacy efforts are still vitally needed. NYLA sent out an advocacy message on Thursday that they had received troubling news that the proposed funding for libraries in the one house budgets were under serious threat, with a possibility of a cut in funding from last year's enacted budget. They are urging people to take part in a phone-a-thon and have set up a very easy way for everyone to participate.

NYLA has a simple online form that you fill out through their online advocacy center and once you fill out the short form, it will provide you with both all the phone numbers you need to call and a short script to read to each office. There are five phone calls to make – each of your representatives (Senate and Assembly), the Assembly Speaker, the Senate Majority Leader and to the Governor. You can find the form [here](#). I made the calls yesterday and it was very easy to do with the online form provided by NYLA.

FLLS Building – Two weeks ago, the compressor in our heating system shorted out, resulting in a shutdown of our heating system. Since that Friday, our building has been without heat. Luckily our compressor was under warranty, and after being originally told that there could be a delay due to a shortage of parts due to COVID, we were notified that the new compressor has arrived. We are hoping for an installation starting around April 7.

Until then, the majority of our staff are working from home due to the cold temperatures in our building. Email is the best way to contact staff. Thankfully our sorting room is on a different compressor and our pages have heat and are able to still pack our deliveries every day.

National Library Week – April 4-10 is National Library Week. I want to take the time to thank all of our library workers who have been going above and beyond over the past year. From expanding your services and creating curbside or contactless pickup and virtual storytimes, to making sure the needs of your patrons and communities were still met even when our buildings were closed, our library staff and trustees continue to work harder than ever. The theme for National Library Week this year is “Welcome to Your Library” and promotes the idea that libraries extend beyond the four walls of a building and that everyone is welcome to use their services.

SCAM ALERT!

[EYE OPENER]

Mom Charged in Deepfake Cheerleading Plot

Raffaela Marie Spone, a 50-year-old mom from Pennsylvania, has been arrested after allegedly leveraging deepfake technology to target several of her daughter's cheerleading rivals.

The incident shows how dangerous deepfake technology is, as Spone used it to tarnish the girls' reputations. Spone allegedly created deepfake videos that showed the girls drinking, smoking, and naked. The videos were then sent to the cheerleaders' coach in an attempt to get them kicked off the team.

The altered content was allegedly pulled from the girls' social media accounts. According to the Hilltown Township Police Department, Spone was previously under investigation after a minor reported being harassed via text message.

Additional girls came forward, experiencing the same thing and part of the same cheerleading team, the Victory Vipers.

Spone allegedly also sent the deepfake videos to the girls via text, along with horrific messages telling them to engage in self-harm. Police arrested Stone after discovering evidence on her phone linking her to the texts and images.

Deepfakes are a looming threat

We need to inoculate our employees against this type of social engineering. KnowBe4 is proud to have recently a training module that trains your users to Spot and Stop the Spread of Disinformation.

This new module covers the red flags that show an email or social media message might be propaganda, and trains the end user to apply critical thinking before they forward damaging disinformation.

Blocks at Check Out

If there is a block on the patron's record, it will display during Check Out. Check with your supervisor for specific library policies. **There will be important information displayed, please do not surpass blocks without reading them!**

Help

- If the patron owes money, select **Patron Status** and collect the fine.
- If the patron has overdue items, select **Patron Status** and renew the items, if possible. Remember that items belonging to other libraries cannot be renewed without permission and items on hold for someone else CANNOT be renewed.
- If the patron has a hold waiting to be picked up, check the item out to the patron.
- If the Patron's card has expired, select **Patron Registration** and update the registration date. Remember to delete the block from the patron's account in the Patron Status **General** page.
- It may notify you that you are checking out an ILL. Follow the procedures listed on **Assigning a Different Loan Period**, i.e. creating a special due date.
