

FROM THE DIRECTOR



Before we head into the holiday weekend, we have many updates for you:

Mask and Libraries – On Wednesday, May 19, NY State started to follow CDC guidance that allows fully vaccinated people to not wear a mask or socially distance in most settings. We happened to have our monthly directors' meeting that day, and we heard from our libraries what they were seeing and experiencing with patrons and masks. Many of our libraries have adopted wording that still requests patrons wear masks in their libraries.

As Chair of PULISDO, I worked with the Western New York Library Resources Council to have attorney Stephanie "Cole" Adams of the Ask the Lawyer service host a webinar entitled "The New Safety: Factoring the CDC's Guidance and NY's Changing Mandates into the Mix at Your Library." Close to 700 people registered in two days for the webinar that took place on Friday, May 21 and roughly 500 participants joined us that day. If you registered for the webinar, you will have received a link to the webinar recording, along with the slides and a handout Cole created for libraries. I hope that the information was helpful to you in deciding how to handle this for your library.

June 1 Minimum Standard for Hours – One last reminder that the New York State Library is requiring that all libraries be able to meet their minimum standard for hours starting June 1. I'm happy to report that starting June 1st, all FLLS libraries will be open their minimum standard hours and none are reporting a hardship meeting this standard. Thank you for your commitment to providing open hours to your communities!

Open Meetings Law Suspension Continued – The adjustments to Open Meetings Law has been extended to June 16. Boards are still able to meet electronically or by phone. We know that adjustments will most likely be ending at some point, so when I have more information, I will let you know.

SCRLC Move into FLLS – This past week, the company DIRTT was working in the Finger Lakes building to transform our collections area and small conference room (which we referred to as our board room) into South Central Regional Library Council's workspace. SCRLC will be renting office space from FLLS and their staff of six will be officially moving into our building on July 1st. Both organizations have had periodic discussions about sharing space with each other for over twenty years, and I'm pleased that we were able to achieve this with the current staff and board of South Central.

Member Services Librarian Position – Nora's last day at FLLS was Thursday, May 20. The job opening for member services librarian was advertised and we accepted applications until Friday, May 21. We received 29 applications, and are starting a series of interviews with candidates starting next week. We are hopeful to have the position filled by the end of June and will keep you updated.

I hope everyone has a safe and relaxing Memorial Day weekend!

SCAM ALERT!

Advanced Persistent Threat Uses New Spoofed Domains in Social Engineering Attacks

Researchers at Cisco Talos warn that the threat actor known as APT36 is using new spoofed, 100%-cloned websites combined with malicious documents to deliver Remote Access Trojans and compromise networks.

“Our latest research confirms that the group continues to create malicious domains mimicking defense-related entities as a core component of their operations,” the researchers write.

Cisco Talos also notes that the threat actor is targeting more verticals than usual in the latest campaign. “While military and defense personnel continue to be the group’s primary targets, APT36 is increasingly targeting diplomatic entities, defense contractors, research organizations, and conference attendees, indicating that the group is expanding its targeting,” the researchers write.

The researchers add that APT36 is putting more effort into making its phishing lures more convincing. “The actors recently deviated from the CrimsonRAT infection chains to make their ObliqueRAT phishing maldocs appear more legitimate,” the researchers write.

“For example, attackers leveraging ObliqueRAT started hosting their malicious payloads on compromised websites instead of embedding the malware in the maldoc. APT36 also used HTTrack, a website copying tool, to create identical duplicates of legitimate sites.

“These examples highlight APT36 heavy reliance on social engineering as a core TTP and the group’s efforts to make their operations appear as legitimate as possible,” the researchers conclude.

These types of attacks happen all over the world, often by state-sponsored hacking groups. You absolutely need a strong human firewall as your last line of defense to block social engineering attacks like this.

POLARIS FAQ

Searching in Leap

While searching for Bibliographic records in Polaris Leap, you may have some difficulty locating titles that contain initial articles.


“The Leap *Bibliographic Title Exact*(*) doesn’t use the Initial articles table like the Polaris Client *Exact match*(*Implicitly truncated*) search does. Going forward I recommend you have your staff change the Bibliographic search to use the *Phrase* option and click on the star to make it the default Bib search when opening the Find tool. In my testing, it provided the closest result set to the current Polaris Client *Exact*(*implicitly truncated*) title search.” - Rex

How to change the default Bibliographic Record search to use the Phrase option:


1. Click/tap on **FIND** after logging into Leap.



2. Click/tap on **Patron** and then **Bibliographic Record** to switch the search object to bibliographic records.



3. Click/tap on **Keyword (All)** and then **Phrase** to switch to a phrase search. This is a special kind of keyword search for multiple words in the exact order in which you entered them.

4. Click/tap on the star symbol. A message will pop up: “Save the current search and column settings as the user’s default” should already be selected. Click/tap **SAVE**.

\$15 Million in American Rescue Plan Act Grants Now Available for Museum and Library Services

Applications for Pandemic Response Funding Due June 28, 2021

Washington, DC—The Institute of Museum and Library Services today announced [a new funding opportunity](#) for museums, libraries, and Native American and Native Hawaiian communities. The \$15 million federal investment will provide direct support to address community needs created or exacerbated by the COVID-19 pandemic and in assisting with recovery.

"Museums and libraries have stepped up to provide their communities with essential services and access to all kinds of health, job, government, educational, social, and cultural resources," said IMLS Director Crosby Kemper. "As places begin to reopen, these institutions will continue to be trusted spaces dedicated to sustaining communities. This funding will allow them to continue lifting up their communities and enabling them to thrive."

The American Rescue Plan Act [allocated funding](#) to IMLS to enable libraries, museums, federally recognized tribes, and nonprofit organizations serving Native Hawaiians by supporting the vital programs and services they provide to their communities.

Proposals to this grant program may continue, enhance, or expand existing programs and services, or they may launch new ones to address emergent needs and unexpected hardships. Reflecting IMLS's goals of championing lifelong learning, strengthening community engagement, and advancing collections stewardship and access, successful projects for this grant program will:

- Advance digital inclusion through approaches that may include, but are not limited to, improving digital platforms, online services, connectivity (e.g., hotspots), and creating digital literacy programs, as well as creating new processes and procedures needed to sustain a robust online environment.
- Support hiring new staff and training or retraining existing staff to ensure a workforce that has the appropriate knowledge, skills, and abilities.
- Build community-focused partnerships, networks, and alliances with organizations with an emphasis on complementing, rather than duplicating, resources and services.
- Support the creation and delivery of online and in-person educational, interpretive, and experiential programs and exhibitions for learners of all ages.
- Provide trusted spaces for community engagement and dialogue to foster recovery and rebuilding.
- Support efforts to collect, preserve, manage, and interpret documentary sources and tangible objects representing all aspects of the COVID-19 pandemic experience.

The deadline for submitting applications is June 28, 2021, with award announcements anticipated in October 2021. A free informational webinar will be made available on-demand on the [IMLS website](#).
