

From The Director



Last week, Governor Cuomo released an agenda for his upcoming budget that once again cuts library aid and construction aid. We have a short period of time until the budget is passed in April to advocate for restorations and show how our libraries help build communities. Here is what we know:

Cuomo's State Library Aid proposal is \$91.6 million. This is \$5 million less than last year. It is far short of the \$200 million

NYLA legislative ask. Cuts to library aid to our system is catastrophic and results in cuts in services and staff at this point. Small gains in library aid keep us in a "status quo" position and means we are often unable to provide new and innovative technology, services, or enhanced e-content when we are faced with rising costs of these services on a regular, sometimes yearly basis.

Construction aid in Cuomo's proposal is \$14 million. This is \$20 million less than last year. The large increase in construction aid last year helped fund projects such as large library expansions and renovations in Ovid and much needed additional insulation in the Finger Lakes Library System's sorting room area. Every single cent we receive from State construction aid is used every single year in our system. Many of our libraries are older buildings that need new lighting, heating and cooling upgrades, and expansions due to increased usage. A cut in construction aid is catastrophic to our libraries that are planning for their future. NYLA's proposal for construction aid is \$75 million.

We know that the 2020 Census is important and that libraries will play a crucial role, especially since this is the first Census that will primarily be conducted online. NYLA proposed \$40 million for library based complete count initiatives. Cuomo's proposal is an astounding ZERO dollars to support the Census efforts.

What can you do in advocacy efforts over the next two months? Attend Advocacy Day in Albany on Wednesday, February 27th. We provide a free bus, schedule your legislative visits for you, and are known for our fabulous snacks we provide free of charge. We provide valuable talking points, legislator biographies, and tips for your visit so you can walk into your scheduled meeting informed and confident in your advocacy ask.

We will be sending our advocacy postcards to our member libraries in the delivery for patrons and staff to fill out. This year we are asking library supporters to write postcards to both their State legislators and Governor Cuomo. Take part in advocacy alert emails that we send out – they are pre-filled for your ease, but can be modified if you would like to make your message more personal. Make phone calls to your legislators and to Governor Cuomo. Look for sample language to use in your phone calls next week from us. If you can't visit your legislator in Albany, make a visit to their local office for a five minute chat on why libraries matter.

Scam Alert!



It Only Takes 1 Phish: Wichita State University Employees Get Fooled Into Losing Their Paychecks

Three employees of the university fell prey to a common scam asking for their credentials, giving cybercriminals access to change banking details.

We've said it time and time again: the bad guys do their homework. In the case of the attack on WSU employees, cybercriminals spoofed the university's payroll system and sent emails to employees tricking them into providing their university ID and password. That was all the attackers needed to gain full control to the employee's profile, personal data, and most importantly – banking information.

It wasn't until a number of employees did not receive their paychecks that the scam was found out. At least three members of the WSU staff fell for the scam, allowing cybercriminals to alter the employee's personal banking details which caused paycheck payments to be routed to the criminals' bank.

The university implied that they would make the employee whole, despite not being responsible for the attack, but indicated that they would not be able to do so in the future should it happen again.

Cybercriminals are in the business of ensuring their efforts pay off. It's the primary reason they target specific industries, businesses, and even people. The more context they can gather (e.g., the payroll system used specifically by WSU), the higher the chances of successfully fooling an employee into taking the bait.

Organizations need to keep employees on their toes with security top of mind to avoid incidents like this. When users step through security awareness training, they are taught about the attacks methods used, and to be suspicious of anything that seems out of the ordinary, scrutinizing email, web pages, and even phone calls – all to make sure your organization is protected against successful attacks.

There are several more items further down with similar incidents, the bad guys have moved toward "payroll attacks" in a big way.

Proposed N.C. Bill Would Require Ransomware Disclosures

North Carolina Attorney General Josh Stein released a report on Thursday that highlights the impact of data breaches on the state in 2018, and paired the report with a bipartisan bill to strengthen breach notifications to include ransomware attacks.

Stein, a Democrat, and N.C. House Rep. Jason Saine, a Republican, introduced a bill to expand the definition of breach to include ransomware attacks, and to tighten breach notification rules. Under the new bill, organizations would have to report ransomware attacks to affected individuals and the state attorney general's office within 30 days.

The bill also would require businesses that own or license personal information to have "reasonable security procedure and practices."

On the consumer side, the bill reduces the notification window for breaches to 30 days, allows people to freeze their credit cards for free, monitor their credit for free for four years if a consumer reporting agency like Equifax suffers a breach, and requires companies to obtain consent when seeking credit scores.

Diving into the details, nearly 45 percent of breaches were the result of hacking, while 26 percent were attributed to phishing, and 17 percent to accidental release. Hacking saw a decline from 2017, while phishing saw the most growth among categories, growing by 11 percent.

Sorting Search Results

After the results list appears, hit **Ctrl+Shift+A** on the keyboard to load all the possible results. Then, click a column header to sort by the values in that column. For example, you can sort a results list of bibliographic records by title, author, format, publication date, call number, and control number.

Limiting Your Search to a Specific Branch: Click the Branches tab to display the Branches tabbed page. By default, all branches and collections are selected. Click **Unselect All** to clear the check boxes for all branches and collections. Click in the box next to the branch you want include in your search.

Limiting Your Search by a Specific Collection Code: When you are searching for bibliographic and item records, you can choose which collection code you want Polaris to search within. The Find Tool's Collections tabbed page lists all the assigned collection codes in the system. By default, all collection codes are checked. Click **Unselect All** to clear the check boxes for all collection codes. Click in the box next to the collection code you want to include in your search.

You can also save time by limiting your search by branch AND collection code within the same tab. Open either the Branches tab OR the Collections tab and click on the plus sign + next to each library or collection code to expand the selection. Under each library, you may select a specific collection code OR under each collection code, you may select a library. Remember to click on **Unselect All** prior to making your choices. The National Federation of the Blind Engineering Quotient program (NFB EQ) is a weeklong summer engineering program for blind and low-vision teens from around the United States. NFB EQ is jam-packed with fun and learning. Participants spend each day engaged in activities designed to strengthen their knowledge of engineering as well as their problem solving abilities. In the evenings, participants explore the local community and participate in various recreational activities. Throughout the week, participants will forge new friendships while increasing their engineering knowledge, problem solving abilities, self-confidence, and independence. Blind and low-vision teens who are ready to learn new things, meet new people, and have an adventure this summer are encouraged to apply.
