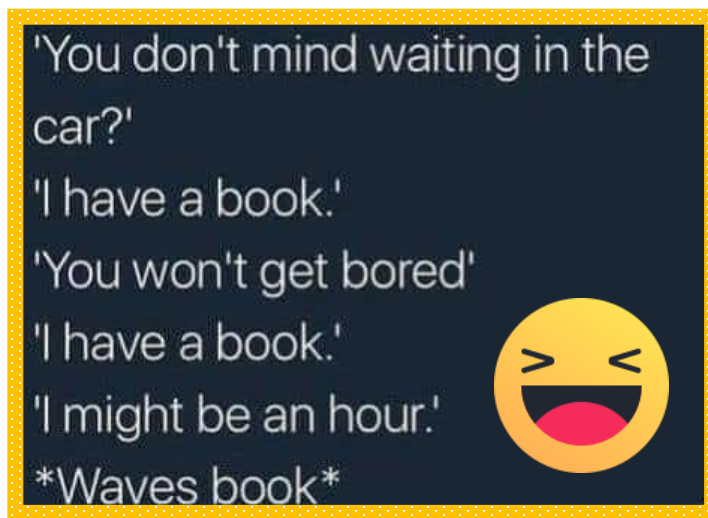

From The Director



I hope everyone is having a happy May and enjoying the slightly warmer weather. We have been working on a variety of projects over the last few weeks and I thought I would update you on some of them.

Referendums – Our libraries are going for a record number of school ballot referendums this spring and we are wrapping up our system work on them. From help with marketing, social media strategies, and creation of Infographics and flyers to

attending library board meetings, local meetings and school board meetings, we feel all of our libraries are on track for successful referendum votes on May 21.

SCRLC – On the morning of Friday, May 3, I attended the South Central Regional Library Council Board meeting. FLLS, Southern Tier Library System, and Four County Library System (under education law) must sit on the SCRLC board and I currently hold the position of Treasurer for the board. At Friday's meeting, we voted on the 2019 – 2020 budget for SCRLC, reviewed membership expectations, studied the cash balance history of SCRLC to help determine what amount the board should be committed to setting aside each year, and had a presentation on the Communities and Libraries partnership project.

DAC – On Wednesday, May 1, we held one of our quarterly DAC meetings at FLLS. DAC stands for the Directors Advisory Council of FLLS. Our three largest libraries (TCPL, Auburn, Cortland) hold an automatic seat, and each county sends two library representatives to our meetings. Discussions at the meeting include an overview of the State Budget and ramifications for both member libraries and FLLS, and an update on state level advocacy efforts and preparation for Advocacy Day 2020. Jen Schlossberg from TCPL gave the group a presentation on bed bug remediation procedures and the group discussed how to create a pest management manual for their libraries.

Bed Bug Remediation Boxes – Due to discussions at FALCONS and at DAC, FLLS has determined that we will be purchasing bed bug remediation boxes for all of our member libraries to keep at their libraries for treatment of library materials. I will be sending out more information to our members next week about this.

Targeted Aid (aka Bullet Aid) Letters – NYLA released a sample form letter for libraries to use when requesting targeted aid money this week. This money is replacing the traditional bullet aid funds. This year, \$5 million of aid is allocated for the Senate, \$5 million for the Assembly, and \$5 million for the Governor. I urge all of our libraries to write request letters to their local assembly members and Senators. Please have a specific project and a specific dollar amount in mind. Examples could be \$3,000 for collection help, \$5,000 for summer reading programs and books, or \$7,000 for new carpeting. If you need help for project ideas or dollar amounts, please reach out to Nora, Jenny, or me for help. Your letters should go out as soon as possible, with NYLA suggesting a deadline of May 10.

Scam Alert!

COPPA: A few tips to keep your child safe online

Online games and websites for kids are everywhere these days – to the point where it's commonplace to see toddlers playing with them, too. And while the internet often offers a positive way for children to explore and learn, privacy concerns are lurking. To help protect children's privacy, the FTC enforces the [Children's Online Privacy Protection Act \(COPPA\)](#), which requires websites and online services to obtain consent from parents before collecting personal information from kids younger than 13.

According to the FTC, [i-Dressup](#), a website allowing users to play dress-up games, and its owners violated COPPA by collecting personal information from kids – including names, email addresses, and user names – without obtaining parental consent and failing to take reasonable steps to protect this information. This led to a breach of i-Dressup's network in August 2016. As a result of the breach, a hacker accessed the personal information and account passwords of over two million i-Dressup users, including at least 245,000 children under 13.

So how can you protect your child online? Here are some tips:

- **Talk to your kids about [what they're doing online](#).** Find out which games, social networking sites, and other online activities your kids are into and make sure you are comfortable with them.
- **Talk to your children about the implications of providing personal information.**
- **Help your kids understand what information should stay private.** Tell your kids why it's important to keep information like Social Security numbers, street addresses, phone numbers, and financial information private.
- **[Learn more](#) about how to protect your child** when he's online.
- **[File a complaint with the FTC](#)** if you think a site has put your child's privacy at risk.

To build capacity and technical support at libraries, and to ensure that libraries are able to preserve patron privacy during the digital census, the Digital Equity Laboratory at the New School has made tools available to help libraries implement best digital security practices for the 2020 Census.

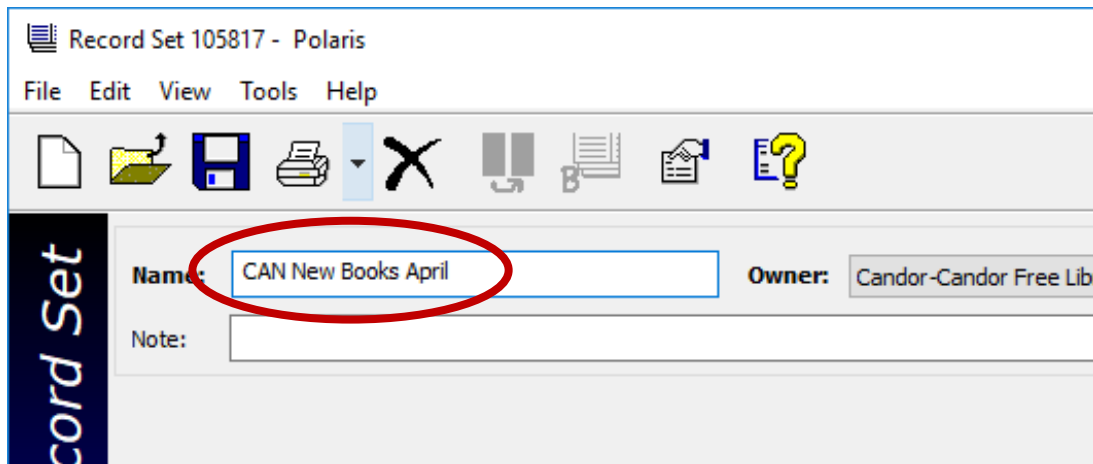

Quick Reminders!

RECORD SET NAMING CONVENTION

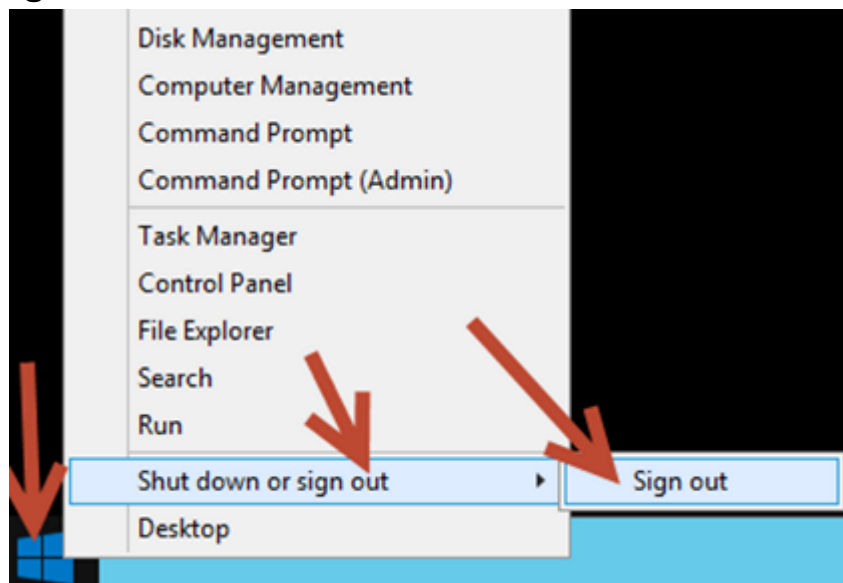
When creating a record set, enter a name to identify this set and any notes you wish to include. Follow the standard naming convention established by FLLS by entering your 3-4 digit library code and then a descriptor, ex. **CAN New Books April**. Improperly named record sets can and will be deleted without advance notification.



Additionally, make sure that you are creating ITEM or PATRON record sets. Bibliographic and Authority record sets will be rarely (or never) used by a member library.

LOGGING OFF CORRECTLY

On the toolbar, go to the **File → Log Off** and select **OK**. After properly logging off, click once on the X in the upper right hand corner of the Polaris toolbar to close it or go to **File → Exit** and select **OK**. Then, go to the Windows button in the bottom left hand corner of the screen, right click, move your mouse to **Shut down or sign out**, and left click on **Sign out**.

ARSL Scholarships

Deadline: May 24

CHECK IT OUT!

Criteria for these scholarships has changed slightly so be sure to read and apply for the one(s) that fit you! These scholarships are for first time attendees so anyone who has **NOT** previously attended an ARSL conference is invited to apply.

This year, four scholarships will be awarded by ARSL. The Dr. Bernard Vavrek scholarship is for current library school students. The Founders scholarship is for current ARSL members who have been working in the library profession for 5 years or less. The Ken Davenport Scholarship is for current ARSL members who have been working in the library profession for 6 to 10 years, and the Angel scholarship is open to current ARSL members who have been working in the library profession for any length of time.
