

Jan Aguirre Customer Service Award: This award is given to a member library employee, volunteer, or trustee who possesses the enthusiasm, grace, friendliness, and patience that Jan had for training and helping others.

From The Director



This year's PULISDO (Public Library Systems Directors Organization Conference) Conference was held on August 15 – August 17. There were three different tracks this year, with a director track, a finance/HR track, and an IT track. On Tuesday, public library system directors had a PULISDO Board meeting. We heard from NYLA and evaluated their list of legislative priorities for 2018. Matthew Kopel from the National Digital Inclusion Alliance spoke to our group about digital inclusion projects and what was occurring both nationally and regionally for that area. On a state level we discussed minimum standards and the upcoming NYLA Conference.

During Wednesday's day-long session, directors broke into small groups to brainstorm on three topics – shared ILS systems, shared delivery, and shared databases. We analyzed benefits of sharing, including costs and staffing issues, as well as downsides to sharing services. This led to our next session on future challenges system directors may face. The changing role of libraries in communities, decreased circulation and library card holders were discussed, as well as some systems struggling to attract a qualified diverse professional staff. We spoke of library consolidation and what that would look like throughout our systems, as well as possible consolidation of public library systems.

How public library system directors support and build relationships with their members was the focus on our afternoon workshop. For all the directors at the workshop, listening to member library concerns and helping them take action was our top priority, in addition to help libraries with innovative projects. Having open communication, a level of trust and mutual respect, and having our members look to us first for guidance were all important to us. We also spoke about challenges we experience when working with our member libraries, such as inadequate funding of our member libraries, having many of our libraries only employing part-time library directors, and ineffective relationships between library boards and library directors. Each of the 23 library directors then shared success stories in our system and advice for other directors.

The State Library will be sending out an email in the next week or two about the public comment portion of the revisions to minimum standards of NY State public libraries. I will send out a reminder email when we are notified, so that people can comment on a state level if they wish.



FAULT LINES IN THE CONSTITUTION THE FRAMERS, THEIR FIGHTS, AND THE FLAWS THAT AFFECT US TODAY CYNTHIA LEVINSON & SANFORD LEVINSON

Fault Lines in the Constitution by Cynthia Levinson

Husband-and-wife team Cynthia and Sanford Levinson take readers back to the creation of this historic document and discuss how contemporary problems were first introduced--then they offer possible solutions. Think Electoral College, gerrymandering, even the Senate. Many of us take these features in our system for granted. But they came about through haggling in an overheated room in 1787, and we're still experiencing the ramifications.

Each chapter in this timely and thoughtful exploration of the Constitution's creation begins with a story--all but one of them true-that connects directly back to a section of the document that forms the basis of our society and government. From the award-winning team, Cynthia Levinson, children's book author, and Sanford Levinson, constitutional law scholar, *Fault Lines in the Constitution* will encourage exploration and discussion from young and old readers alike.

Polaris Tip of the Week

Adding Blu-ray/DVD Combos to Your Collection

If you are going to circulate a Blu-ray and DVD in one case please indicate this on your quick bib by putting Blu-ray and DVD after the title (245 tag) ex. Pirates of the Caribbean (Blu-ray and DVD).

It would be your best bet to split them and make Blue-ray d. 1 and the DVD d. 2. In the **prefix** if it is a Blu-ray use Blu-ray or if it is a DVD then use DVD.

If you are keeping them as a combo, the call number prefix would be "Blu-Ray + DVD." See item A20517801575 as an example. In any case, the item will always be classified as a DVD in the material type, loan period, and fine code.
