## From The Director



I would like to take this opportunity to remind all of our libraries about Open Meetings Law and executive sessions. It has come to my attention in the past few weeks that there have been three possible violations of executive sessions and I cannot stress to both directors and trustees how serious these violations can be for your libraries.

<u>All</u> public libraries in New York, including association libraries, are subject to the <u>Open Meetings Law</u> (please see Education Law §260-a and Public Officers Law, art. 7). This law requires that board meetings must be properly posted and advertised and open to the public. In addition, working sessions of the board (even if they are not formal meetings), must be advertised and open if a quorum of the board is expected to attend. Education sessions in which the

board does not conduct business are exempt from Open Meetings Law. An example of this exemption is if your board did a trustee training or a technology training session.

While executive sessions do allow for the public and the news media to be excluded, they must be convened during an open meeting for a **limited** number of very specific purposes. These purposes include:

- 1. Discussions regarding proposed, pending or current litigation;
- 2. Collective bargaining negotiations pursuant to Article 14 of the Civil Service Law (the Taylor Law);
- 3. The medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation;
- 4. The proposed acquisition, sale or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof.

An executive session is convened only as part of a public board meeting, not as a separate meeting. The board must vote to enter executive session and state the general nature of the session for its minutes. The board may invite advisors into executive session, such as the library director, the system director or a consultant, or the library's lawyer. The library director should almost always be invited in to an executive session unless the board is discussing a personnel matter related to that person.

Boards often use executive sessions to discuss matters with which they feel uncomfortable in a public setting, yet are not defined within the law. This is not only inappropriate, it is illegal.



## Scam of the Week



### Scam of the Week: "Fake-tortion" Phishing Attacks

There is a new, sophisticated email scam you need to watch out for. Bad guys first send emails with links to inappropriate websites to business email addresses,

and then follow up with extortion threats, claiming your workstation is infected and that they "know what you just looked at", and say they will send a video to all your email contacts, because they "recorded what you were watching".

Company email addresses were specifically targeted, which would have added additional pressure to potential victims "since it implies that a recipient's work PC was infected and may therefore taint one's professional image". "It is important for users to verify claims from the internet before acting on them," he said. "Most online attacks today require a user's mistake before actually becoming a threat. This is something that can be mitigated by addressing the weakness of the human point." We agree.

But Leonard said the scale of this campaign suggested the scammers were bluffing about having compromising information. "If the actors did indeed possess personal details of the recipients, it seems likely they would have included elements [such as name, address or date of birth] in more targeted threat emails in order to increase their credibility.

This led us to believe that these are simply fake extortion emails. We ended up calling it 'fake-tortion'."

If this type of scam email makes it through the spam filters into your inbox, do not click on any links, do not reply, and delete the message (or click on the Phish Alert button). Do not download any software to check your computer for viruses, but follow procedure to report these types of criminal emails. Remember: "Think Before You Click", it is more important than ever these days.





### **Polaris Tip of the Week**

### Volume Field in BOCD

The volume field is rarely used in a BOCD item record. The field is primarily used for the disc count in a multi-part DVD or Blu-Ray set.

When entering a typical BOCD item into Polaris, leave the volume field blank. Enter "Check for X discs" in the **Free text Block** field on the Notes and Notices page of the item record. This block encourages staff to check for the number of discs at Check In and Check Out.
