Both the original incorporation (1883) and our amendment (1983) state a number or members to be on the board but not the term length. Our current by-laws (2016)state: "There shall be no less than five nor more than twenty-five Trustees. Each Trustee shall hold office for a three-year term. No Trustee shall serve for **Note:** more than (2) consecutive terms of three (3) years each. After a lapse of one year, any person who has served as a Trustee shall be eligible for re-election." In the case of officers our current by-laws (2016) state: "The officers of the Board shall consist of a President, Secretary and Treasurer. All officers shall be elected by the Board for a term of one (1) year and may serve consecutive terms."
