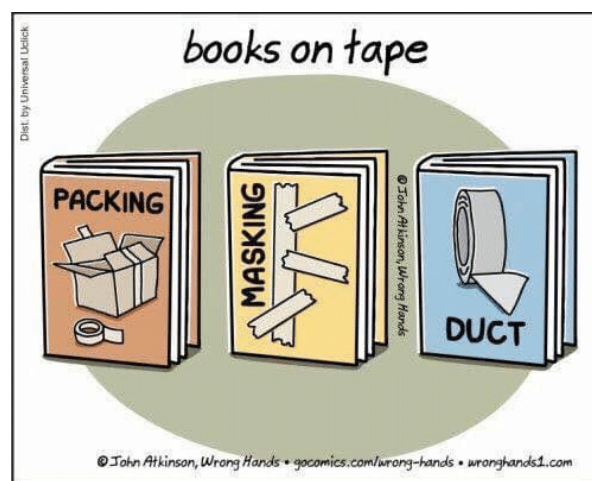

From The Director



Thank you to those who attended our 61st FLLS Annual Meeting on Friday, October 18! We had over 85 member library trustees, directors, staff and volunteers join us at the beautiful Shepard Hills Country Club in Waverly. If you would like to see photos from the day, please be sure to check out our Facebook and Instagram pages.

Our largest system meeting of the year takes months of preparation and planning by numerous FLLS staff members. Our administrative assistant, Diana, finds our location for us when we switch counties, and does all of the menu preparation with the facility. Kristi Downham prepares our Annual Report that we distribute during the meeting and helps with overall planning for the day. Librarian Jenny Shonk prepares our slideshow that plays during the meeting, and also organizes our raffles. Eric and Rex from the computer network services department make sure all our technology needs for the day are met. Librarian Nora Burrows helps with check-in desk along with Kristi and Diana.

During the business portion of our meeting, we heard from Jean Currie, our regional representative from the Library Trustee Association. Jean went over the administrative changes at LTA and explained the process of LTA joining NYLA as a section. Jean and I also discussed the importance of trustee education, especially with upcoming proposed legislation that will require trustee education in the future.

The Chair of our Policy Committee, Martin Toombs, explained recent FLLS Board Bylaw changes to account for the requirement of sexual harassment prevention training and the to cover the removal of trustees, and the membership ratified those changes. The membership also elected two new Finger Lakes Library System trustees. Cynthia Mannino was elected for the At-large trustee position and is a trustee at the Ulysses Philomathic Library in Trumansburg. Micci Bogard was elected for the Seneca County trustee position and is a trustee at the Lodi Library. Both trustees start their terms in January 2020.

Our speaker this year was Stephanie “Cole” Adams. Stephanie is the attorney for the “Ask the Lawyer” service through our regional library council. Ms. Adams has a deep connection to libraries after working at her hometown library in New Hartford, NY and her college libraries. Her talk, “Legal Issues Facing Libraries Today”, covered a variety of topics, including library bylaws, policies, job descriptions, copyright, how to deal with law enforcement requests and more. Stephanie’s presentation was our highest ranked presentation as gleaned from the evaluations from the meeting.

A reminder that our future Annual Meeting committee is still meeting and is evaluating survey responses to determine what our membership would like to see during future meetings. We met on Monday, October 21 to debrief about this year’s Annual Meeting and to start going through survey responses. The goal for the committee is to give a recommendation to the FLLS Board by January.

Scam Alert!

Social Security is Not Trying to Take Your Benefits

We've seen a new twist on the Social Security Administration (SSA) scam recently. Check out this SSA imposter robocall, which says your benefits will end. (That's not true, by the way.)

If you get a call like this, do not press 1. Instead, just hang up and remember:

- Your Social Security number is not about to be suspended.
- The real Social Security Administration will never call to threaten your benefits.
- The real SSA will never tell you to wire money, send cash, or put money on a gift card.

The Social Security Administration scam is the number one scam reported to the FTC right now. People filed nearly 73,000 reports about Social Security imposters in the first six months of 2019, with reported losses of \$17 million. You can explore the data about imposter scams and losses at <https://www.ftc.gov/enforcement/data-visualizations/explore-data>.

So if you're getting these calls, you're not alone. Tell your friends and neighbors about this scam. Tell them to hang up the phone. And then to report it to the Federal Trade Commission.

“Genealogy” Website Offers Personal Information for Free

On a recent podcast, Jenny heard about a website called <https://www.familytreenow.com/>. This website offers up your personal information to anyone for free. Information can include birthdate, addresses, phone numbers (including cell phones), known associates, and known relatives.

Luckily, you can opt out! Visit <https://www.familytreenow.com/optout> and follow the steps listed below:

1. After you click the 'begin' button below, you will be taken to the search page. Run a search for yourself.
2. After you have found yourself in the results, click on the record detail. Verify that this is yourself and not just someone else with your same name.
3. After you are 100% sure this is your record, click the big red 'Opt Out' button that is on the page.
4. You are done. Please allow up to 48 hours for your request to be processed. Once it's processed that record will be removed from all places on the site. Note: If you have multiple records that need to be removed, repeat steps 1-4.

Friends of Tompkins County Public Library Education Grants Deadline is Coming Up!

Dear Librarian,

As chair of the Education Grants Committee of the Friends of the Tompkins County Public Library, I'm happy to inform you that once again this year the Friends is offering local librarians, library assistants, and future librarians **grants to continue their professional education**. These grants are available to staff members of libraries (including school libraries) within Tompkins County to partially cover costs of attending professional meetings, workshops, training sessions, and conferences, and to defray the cost of course work. You and your staff members are eligible to apply for such funding. Awards amounts are typically in the several hundreds of dollars.

The applicant must provide information about the content of the proposed program, associated costs, and any other available financial support, as well as two letters of recommendation, one from a supervisor. There is a link to a PDF of the application form on the web site of the Education Grants Committee <http://www.friendsoftcpl.org/grants/education-grants/> and a description of the committee's program to support continuing educational opportunities for staff members of Tompkins County libraries. Completed applications should be submitted electronically to edgrants@booksale.org by October 28, 2019. Applicants who are unable to apply electronically should contact me using the information below. Grant recipients will be informed by November 8, 2019.

We hope you and your staff will be able to take advantage of the grants offered by the Educational Grants Program. We look forward to hearing from you.

Digitization projects are also encouraged, as they allow materials to be accessed regionally through New York Heritage, New York State Historic Newspapers, and the Empire Archival Discovery Cooperative.

For 2020, applications are especially encouraged for:

- projects involving oral history
- partnerships increasing representation of and with communities that have been historically and systematically oppressed.
