### From The Director



Here are some updates for you:

**Tompkins County Funding** – On Monday, October 19, I attended a budget amendment meeting of the Tompkins County legislature. I had been notified on the 16<sup>th</sup> that the legislature was proposing to give Finger Lakes an additional \$5,000 and the five rural Tompkins County libraries an additional \$3,000

each to help offset the 12% budget cut received from Tompkins County. After a few questions about our budget cuts in general, the legislature voted unanimously for the budget amendment. We are extremely grateful and thankful for the Tompkins County legislature and their commitment to the libraries in their county.

Cluster Action Initiatives – We are seeing an increase in positive cases in some of the counties in our service area. Cortland County especially saw a dramatic increase two weeks ago. At our recent directors' meeting we discussed the comfort level of our drivers and pages at FLLS, and if our member libraries would like to continue getting deliveries from libraries in counties with large numbers of positive cases. Our members all agreed that they would like delivery to continue, knowing that if numbers increase substantially in the future, we may have to temporarily suspend delivery on a county-by-county basis. This is in line with the Governor's proposed cluster action initiatives which places counties in yellow, orange and red zones.

At a public library system level, system directors have been reaching out to our county executives in our service area to seek guidance and interpretation of how libraries fit into these cluster initiatives. It seems that the regional control rooms are currently meeting twice a week, like they did in the spring when businesses were beginning to re-open. Speaking to our county executives gets libraries on their radars once again and we are awaiting clarification from our counties on what will happen to libraries if one of our counties is placed in a yellow, orange or red zone.

Novelist subscription ended – Due to the severe budget cuts our system is facing, we had to make the hard decision to discontinue the Novelist database subscription. Novelist is a readers' advisory resource that suggests read-alike book titles or authors and provides helpful information about book titles or series. Our libraries have been notified and we have shared social media posts that our libraries can share with their patrons.

**New Minimum Standards Training** – FLLS provided our member library directors with training on the new minimum standards for public libraries that go into effect on January 1, 2021. A reminder that all of our libraries in our system are currently compliant with all minimum standards and no variances were needed this year. Sarah will be providing training for trustees on this topic in November.

## Communications Part 1: Stemming the Tide Thursday, November 12, 10:00am

This year, the methods we use for communication have increased, as well as the frequency of communication. Information is arriving in your inbox, through social media tools, on your phone, and other methods. How do you tame these streams and stay on top of the messages you are receiving? This webinar will help you think through the ways you are receiving information and how to ensure that you see important communications. We will also think through what your communication preferences are, and how to communicate your communication preferences to others. At the end of this workshop, you will have a set of action items to help you tame those overflowing streams of information heading your way.

# Communications Part 2: Being Understood Thursday, November 12, 10:00am

We don't just receive information; we are also senders of information. In this webinar, we will consider how to use the preferred communication methods of our teammates, and how to seek compromises. Because of the dominance of email, we will discuss email best practices, and then consider best practices for social media (both as individuals and as representatives of our organizations). At the end of this workshop, you will have ideas for new practices to implement, as well as ideas for possible staff or community member training.




### **Polaris Hold Requests & Maintenance**

#### Find unclaimed holds in the Request Manager!

Open Request Manager by going to **Circulation > Request Manager** on the Polaris toolbar. Click on **Status:** and select **Unclaimed**. Please remove any of the items listed there from your holds area and check them in so that they are sent to the appropriate library. Some libraries have a procedure in place to call and remind patrons about their holds prior to the unclaimed date. Please be mindful of unclaimed items to ensure that all patrons are receiving their hold requests in a timely manner.



You can also change the **Status:** to **Expired** and click on an item and then the **Reactivate** button to reactivate a hold. Change the **Status:** to **Not Supplied** and check if your library is now able to fill any hold requests listed there.

Libraries Transforming Communities: Focus on Small and Rural

Libraries Grant Opportunity

Deadline: December 2, 2020

#### **Award Information:**

Libraries serving small and/or rural communities will be selected to receive an LTC community engagement implementation grant over the course of two application periods. In the first application period (September - December 2020) at least 200 libraries will be selected. The second application period (January - March 2021) will provide grants to at least 450 libraries serving small and/or rural communities.

Library staff will apply the skills learned from the LTC: Facilitation Skills for Small and Rural Libraries e-course and facilitation guide to address community need through library service. Libraries selected for funding will receive:

- \$3,000 to support costs related to their community engagement project
- Professional development consisting of the LTC: Facilitation Skills for Small and Rural Libraries asynchronous e-course and facilitation guide (required for all project directors)
- A suite of online resources developed to support local programs including template press releases, social media messaging, logos, digital promotional materials and template letters that can be used to notify local leaders/officials about the library's project.
- Technical and project support from the ALA Public Programs Office throughout the grant term, such as access to:
  - o Online learning opportunities for grantees intended to assist project directors in promoting their conversation, completing grant reporting requirements and participating in evaluation
  - o Community of practice for project directors and staff

#### **Eligibility:**

- Applicants must have a membership with either the American Library Association OR the Association for Rural & Small Libraries.
- This opportunity is open to all types of libraries serving small and/or rural communities in the U.S. and U.S. territories.
  - o The Institute for Museum and Library Services (IMLS) defines libraries serving small communities as those with a legal service area population of 25,000 or less and a rural community as one that is more than, or equal to, five miles from an urbanized area.
- Only complete and eligible applications that are received on time will be reviewed.
