

FROM THE DIRECTOR



I hope everyone is enjoying the beginning of fall! Here are some updates for you:

Construction Aid - Lauren Moore, Assistant Commissioner for Libraries and State Librarian, announced on September 15 that the NYS Library, in partnership with New York's 23 public library systems, awarded \$14 Million in State Aid for Library Construction

funds for the FY2020-21 projects. Throughout the State, there were 135 projects. These awards are typically received earlier but were delayed due to COVID-19. A list of all of the FY2020-21 State Aid for Library Construction projects is posted on the <u>State Library's</u> <u>website</u>. Finger Lakes had three member library projects: the Seymour Library in Auburn, the Waterloo Library and Historical Society and Tompkins County Public Library. Those three projects totaled \$421,048.

Our current cycle of library construction projects will be voted on this Wednesday, September 29 at the Finger Lakes Library System Board of Trustees meeting.

NYLA Governance Task Force – The task force met earlier this week to go over our final revisions for the New York Library Association's bylaws. Our work as a task force is to both review and update the bylaws and make necessary revisions and suggestions. The task force has agreed that we are satisfied with our revisions and have asked that it be passed on to legal counsel for review. The task force is aiming for the legal review to be complete by early October and the bylaws to be on the October 7 NYLA Council agenda. Once it passes NYLA Council's review, it will go out to the full NYLA membership for review and comments. A vote on the bylaw changes will take place on November 4 during the NYLA Conference.

Now that our bylaw review is coming to a close, the task force will be briefly looking at policies and other NYLA documents for suggestions and review. The NYLA President is also in the process of forming a search committee for the Executive Director position. I will be able to share more information on the search process and the committee shortly.

FLLS Board of Trustees – The FLLS Board of Trustees will be meeting via Zoom on Wednesday, September 29 at 5:30pm. We have many agenda items this month including: our audit review, our 990 review, voting on library construction aid projects, a FLLS construction project that will be for extra insulation for a specific area of our building, and our Plan of Service. A reminder that our Plan of Service actually is three different documents: our regular Plan of Service for the next five years, our Free Direct Access Plan, and our Central Library (TCPL) Plan of Service for the next five years.

FLLS Annual Meeting – Look for more information next week about our upcoming Annual Meeting, which will be held via Zoom on Friday, October 15 at 10am. During this meeting, we will voting in new trustees, holding a brief business meeting, and I will be sharing updates with directors and trustees. We hope to see you, albeit virtually, this year!

SCAM ALERT!

A New Phishing Attack on Microsoft 365 Users Leverages Open Redirects To Avoid Detection

The use of open redirects from legitimate domains makes phishing emails that much more believable and credible, obfuscating the dangerous nature of these attacks.

In the ongoing saga of attacks on Microsoft 365 users, security analysts at Microsoft recently announced a widespread attack that utilizes open redirects – a technique used in web development to point to the URL visitors of a website should be taken to once the initially-visited page is done processing the visit.

A simple example of an open redirect is the following: [https://]example[DOT]com/redirect[DOT]php?url=[http://]attacker[DOT]com

According to Microsoft, attackers will use a bit more trickery to fool those that choose to hover over links in emails before clicking on them, embedding a malicious URL within what appears to be a trusted URL (note the red portion of the screenshot at the blog)

In many cases, redirects to malicious URLs first take visitors to Google reCAPTCHA pages to further obfuscate the nature of the final destination from security solutions designed to evaluate email links.

While evaluating destination URLs via hovering over links in an email is definitely a good security practice, threat actors are becoming wise to this and are taking steps such as those mentioned above to make it even more difficult to spot a malicious link.

Users should be taught via Security Awareness Training to be more mindful of the actual message being sent – if unsolicited, it should be treated with at least a bit of distrust and scrutiny, being certain it is legitimate before engaging with links – benign or malicious.

Placing Holds: Multi-Request in Polaris Leap

You can also place multiple holds in Polaris Leap. This function could be used for a patron who would like multiple books by the same author or books of the same genre/subject. Using the search bar at the top of the screen, search for the patron by name or barcode. After locating the patron's account, click on the **Holds/Held** section. Then, click on **More** → **Multiple Holds**.

AWARDS & GRANTS

Friends of Tompkins County Public Library Education Grants

The Friends is offering local librarians, library assistants, and future librarians **grants to continue their professional education**. These grants are available to staff members of libraries within **Tompkins County** to partially cover costs of attending professional meetings, workshops, training sessions, and conferences, and to defray the cost of course work. Awards amounts are typically in the several hundreds of dollars.

The applicant must provide information about the content of the proposed program, associated costs, and any other available financial support, as well as two letters of recommendation, one from a supervisor. ALA has announced a new grant for libraries designed to spark conversations about American history and culture through an examination of the women's suffrage movement. To qualify for this grant, the applying institution must be a library (public, tribal, school, academic, or special) residing in the U.S. or U.S. territories. Read the <u>grant</u> <u>guidelines</u> and <u>frequently asked questions</u>.

Through Let's Talk About It (LTAI): Women's Suffrage, participants will read a series of books curated by humanities scholars and discuss the people and events from this often under-taught part of U.S. history. Twenty-five libraries will be selected to receive a \$1,000 stipend to support programming costs, ten copies of five themed books, access to programming guides and support materials, virtual training on the LTAI model, a suite of online resources and more.
