# FROM THE DIRECTOR

There are many NY State updates for our libraries in this newsletter, including:

**NY State Budget** – We finally know Governor Hochul's Executive Budget and for the first time in over six years, the proposed funding for library aid has increased. This year's Executive Budget includes:



#### Library Aid: \$96.1

The proposed funding is \$2M more than what was in last year's enacted state budget. While this depicts a moderate increase to our general aid, it fails to acknowledge the crucial role libraries serve in our communities and the contributions they make to our state's education system.

#### **Library Construction Aid: \$14M**

For the second year in a row, the Executive has proposed to reduce the State Library Construction Aid Program by \$20M. A cut in library construction aid means that our aging libraries would not be able to make necessary renovations, upgrade HVAC or other heating systems, and more.

#### Love Your Library Fund: Release of 150K for Summer Reading

The Love Your Library Fund was established nearly 17 years ago. There are two separate sources for the Fund; the first is a special license plate and the second is a contribution made via a corporate or personal income tax return. The "Love Your Library Fund" is used exclusively to support the NY Statewide Summer Reading Program. To distribute the funds, explicit language needs to be included in the annual budget.

Directors and trustees were sent emails asking them to participate in a virtual advocacy alert to State leaders. Please consider filling out the advocacy alert – it is quick, easy and you can customize it with your own messaging if you would like.

**Advocacy Day** – A reminder that Advocacy Day is Wednesday, March 2. All Advocacy Day efforts this year will be virtual as the legislature is currently closed to visitors. Over the next week or so, FLLS is working with our neighboring public library systems and our regional library council to schedule virtual meetings and we will be sending out more information to directors, trustees, and library supporters.

Annual Reports – New York State has unlocked the 2021 Annual Reports portal and you may now login and begin working on your report. A reminder that Jenny Shonk is the contact person at FLLS for Annual Report questions. Reports are due to FLLS by Monday, February 28. A reminder that Annual Reports must be board approved, so a board meeting in February must occur to review and approve your library report.


**Delivery of COVID-19 tests** – Earlier this week, FLLS worked with the Tompkins County Department of Emergency Response to pick up and distribute 3,000 at-home COVID-19 test kits to all libraries in Tompkins County. A big thank you to Tom Smith, our Fleet Manager, for his help with the delivery and distribution of the kits. Seneca County libraries also received and distributed at-home test kits this week.





# **SCAM ALERT!**

# FBI: Beware of a New Google Voice Authentication Scam – Even if You Don't Use Google Voice!

A new advisory warns of a scam that can affect literally anyone designed as a precursor to additional vishing scams and/or to perform Gmail account takeovers.

If you're unfamiliar with Google Voice, it is a service where Google provides you with a virtual phone number so you can make and receive calls and texts. Assuming you are unfamiliar with it, you may be wondering what's all the excitement about?

According to a new FBI advisory entitled "Building a Digital Defense Against Google Voice Authentication Scams," the FBI outlines a scam that involves a threat actor responding to a personal ad – they use the example of selling a couch on craigslist or some other site – and says they want to make sure you are legitimate so they don't get scammed by sending you an authentication code from Google.

What's really happening is the scammer is setting up Google Voice using your phone number as the primary number and using you to assist them with Google's authentication process during setup. Once completed, the threat actor has a new Google Voice account tied to your mobile phone, so they can carry on without worrying about having it tied to their phone. Additionally, the code being sent could be purposed to allow them access to reset the password to your Gmail account.

Organizations relying on Gmail for corporate email should be specifically concerned about the ramifications of such a scam; with access to one of your internal email accounts, threat actors can easily spray out phishing emails designed to provide endpoint access or install ransomware.

# Polaris Item Maintenance Part 2


Topics included: creating and using record sets, different types of bulk changes, common ways to change your items from "New" to "not new" (including a SQL search), and working with templates.

# **ALA Libraries Transform Communities Engagement Grant**

ALA invites library workers to apply for the <u>Libraries Transform Communities</u> <u>Engagement Grant</u>, an annual award supporting innovative and meaningful community engagement efforts in libraries.

The Libraries Transform Communities Engagement Grant recognizes, promotes and supports innovative and meaningful community engagement efforts in libraries. It will provide two grants of \$2,000 for a school, public, academic, tribal or special library to expand its community engagement efforts.

Libraries are invited to apply by designing and outlining activities for a library-led community engagement project. Community engagement is the process of working collaboratively with community members – be they library patrons, residents, faculty, students, or local organizations – to address issues for the betterment of the community.

Each year, the grant will focus on supporting a community engagement project with a specific theme. For the 2021–2022 cycle, libraries are invited to submit applications for a community engagement project that focuses on a social justice issue of importance in their communities. Examples of potential topics include racial justice, climate justice, or addressing the digital divide. Libraries should work collaboratively with community members and at least one partner organization to develop a project that addresses a local issue and builds upon community assets.
