April was full of collaboration as I continue to work with Emily from Cornell Cooperative extension's Energy Navigators program. Four of our member libraries have booked her Tiny Power House tour as part of their Summer Reading program. We've discussed book selections for storytime and looked at MOUs and teen programming. (Our libraries received funding from the Rosen Library Grant Cycle for this.) I also had an opportunity to work with Hope Decker and Lorie Brown from STLS. Hope is a facilitator with MIT's Public Library Exchange program and offered a session on facilitating creative learning with a STEAM based Paper Circuits program. Lastly, I've been in touch with all of our libraries as well the Museum of the Earth, the Sciencenter and my colleagues here at FLLS as we work to make the Museum Pass Project a reality. FLLS received funding through the Community Foundation of Tompkins County Library Grant cycle to create kits with museum passes and related books for each of our member libraries.
