FROM THE DIRECTOR

Happy October! As we head into fall, here are some things we have been working on at FLLS:

Annual Meeting – A last reminder that the Finger Lakes Library System Annual Meeting will be held virtually on Friday, October 14 at 10 AM. While trustees of our member libraries are the voting members during our business meeting, the meeting is appropriate for library staff, directors, and trustees.



Our business meeting will be short and will include: approval of minutes from 2021, one trustee election, and remarks from the FLLS Board of Trustees President, Martin Toombs. Our trustee election is for a Tioga County representative, and FLLS trustee Patricia Schaffer is running unopposed for a second term.

I will be giving remarks that will include State updates for both directors and trustees, some helpful reminders for trustees about upcoming Trustee Education requirements, and then an overview of our member libraries and FLLS activities this year.

Our goal is to be less than an hour, as we know everyone is busy. A reminder that our intent is to hopefully transition back to an in-person Annual Meeting next year so that we can network and enjoy seeing everyone in person.

2023 Funding – Many of our libraries are hard at work finalizing 2023 budgets and even planning for their 2023 referendum ballot vote. I have spoken with a few boards over the last few weeks about the benefits of going above the tax cap while weighing the risks of voter perception in a time of inflation, a recession, and high grocery, gas and electric prices.

While the county budget requests for Tioga County libraries and Tompkins County libraries are complete, the Seneca County libraries will be meeting with the Seneca County legislature next Tuesday. The five libraries in Seneca County created a fantastic and informative video that was sent to legislators before the upcoming meeting highlighting what county money is used for as well as all of the services, programs and outreach the libraries do. I will be joining the Seneca County libraries at the legislature meeting to lend support.

The Great Give Back – Are you aware of the Great Give Back, happening in many of our libraries this month? This community service initiative was created by the Suffolk County Public Library Directors Association and the Suffolk Cooperative Library System, in conjunction with the Nassau Library System. The program provides a day of opportunity for the patrons of public libraries of NY State to participate in meaningful, service-oriented experiences. FLLS and SCRLC staff are collecting urgently needed items for the Tompkins County SPCA and are excited to participate along with our libraries.

FLLS Closed – A reminder that FLLS will be closed on Monday, October 10 in observance of Indigenous Peoples' Day. There will be no deliveries on Monday. Both routes will be receiving deliveries on Tuesday, October 11.

SECURITY HINTS & TIPS: Browser Notifications

What Are Browser Notifications?

Most internet browsers allow websites to offer browser notifications. The first time you visit a website that offers browser notifications, you will see a pop-up message at the top of your browser window asking you to either allow or block notifications. If you choose to allow them, browser notifications can be displayed at any time, even when you are not on that website. These notifications are typically used for things like blog updates, social media interactions, and upcoming sales. Unfortunately, cybercriminals can also send their own malicious browser notifications to steal your money and information.

How Do Cybercriminals Use Browser Notifications?

Cybercriminals can use two different methods to send you malicious browser notifications. They can either hijack a legitimate website and offer fake notifications from that website, or they can trick you into allowing notifications while visiting a malicious website. For example, in one scam, cybercriminals used a malicious website that appeared to be a video player and instructed users to click "Allow" before they could play a video.

Once cybercriminals are able to send you browser notifications, they can use the notifications in several ways:

- They can display excessive pop-up messages, inappropriate content, or other disruptive material in your browser. This tactic allows cybercriminals to hold your system hostage while they demand a ransom.
- They can send you malicious advertisements, also known as malvertising. Malvertising is when cybercriminals use ads to spread malware, trick you into providing sensitive information, or steal your money using fake storefronts.
- They can include malicious files and code within browser notifications. If you click on one of these malicious notifications, your system may be automatically prompted to download a piece of malware.

Hints and Tips to Stay Safe

Use the tips below to stay safe from malicious browser notifications:

- Think before you click! Whether it is a browser notification or another kind of pop-up message, always read and consider a prompt before taking action.
- Check the permissions settings within your browser and only allow notifications for websites that you know and trust. Most browsers include a list of websites that are allowed to send you notifications. Some browsers also allow you to globally block notifications for all websites.
- Keep your browser and other software up-to-date. Software updates often include security patches that help close known vulnerabilities. We recommend enabling automatic updates to ensure that your browser is always up-to-date.

Smithsonian traveling exhibition grant: Exploring Human Origins

Deadline: November 7, 2022

The American Library Association (ALA), in collaboration with the Smithsonian National Museum of Natural History's (NMNH) Human Origins Program, invites applications from public libraries interested in hosting the traveling exhibition Exploring Human Origins: Promoting a National Conversation on Human Evolution.

The exhibition will travel the U.S. from May 2023 through May 2026. **Six public libraries** will be selected to present the exhibition in their communities for a period of six to nine weeks each, with library host periods available each summer and winter. Experts from the NMNH Human Origins Program will present in-person or virtual programming at the participating libraries.

The goal of this traveling exhibition and public programs is to create an opportunity for audiences across a wide spectrum — from those who do not question the scientific study of human origins to those who are troubled by its findings — to engage the complex field of human evolution research in ways that are understandable, fulfilling, captivating, and relevant. By touring the exhibition and providing public programs to communities across the U.S., the exhibition sponsors endeavor to create a respectful and welcoming atmosphere for public audiences to explore how, when and where human qualities emerged.
