FROM THE DIRECTOR

Here is a recap of our 65th FLLS Annual Meeting held on October 13, 2023:

Over 80 library staff, directors and trustees joined us at the Hilton Garden Inn in Auburn, NY for our first in-person Annual Meeting since 2019. A big thank you to all who attended and had the opportunity to network and speak with other libraries and trustees. A very large thank



network and speak with other libraries and trustees. A very large thank you to the FLLS staff who assisted that day: Diana Leigh and Heidi Eckerson who ran the registration table and to Jenny Shonk for highlighting our outreach services and a look back at FLLS over the years with our scrapbooks.

We started our meeting hearing from Jean Currie, Chair of the Library Trustee Association Section of NYLA. Jean gave an overview of LTAS, why libraries and their boards should consider joining that section, and an overview of the newly updated Trustee Handbook that will be coming out next month. FLLS is ordering plenty of print copies of the new Handbook and will be distributing them to our libraries in November.

FLLS Board President Martin Tombs ran the business portion of our Annual Meeting. Earlier in the year, the FLLS Board of Trustees approved two bylaw changes and our membership ratified those changes during our October 13 Annual Meeting. They were changes that allowed voting trustees from each member library to vote in trustee elections (the former bylaws allowed for respective county voting and at-large trustee voting only) and a change in our quorum for voting to one-third of the libraries that are members of the Finger Lakes Library System.

The FLLS membership voted in two new trustees to the FLLS Board of Trustees. Priscilla Berggren-Thomas was elected for Cortland County representation. Priscilla is the retired director of the Phillips Free Library in Homer. Kasia Maroney was elected for Tompkins County representation. Kasia is a fine arts conservator specializing in three-dimensional objects and works with museums, libraries, universities and galleries. We welcome both of our new trustees to the Board! We also want to send a special thank you to Sue Heavenrich, who will be leaving our Board at the end of December!

Our speaker for our Annual Meeting was Darcy Lipp-Acord, a Youth Services Librarian at Campbell County Public Library in Gillette, Wyoming. For the past two years, Darcy and her staff have been dealing with a well-organized community effort to censor books and discredit the library and library staff. Her presentation provided training to our libraries on how to identify common strategies used by book-challenging groups and linking these with abusive behaviors typically found in domestic relationships. She also discussed strategies for front-facing staff in responding to potentially abusive behavior in patron interactions. We received incredibly positive feedback about Darcy's presentation from both library staff and trustees and appreciate her coming to our area to speak to us. Darcy's slides were sent out via email today.

Like our member libraries, FLLS creates an annual report to our community and released that during our Annual Meeting. A large thank you to Jenny Shonk from FLLS for creating these reports for us! You can find our current reports at https://www.flls.org/about-us/.



FLLS LibTour '24



AWARDS & GRANTS

Solar Eclipse Mini-Grants Program Invites Proposals



The American Astronomical Society (AAS) Solar Eclipse Task Force invites proposals for small grants to fund programs, activities, and events that will engage the public with the April 8, 2024, solar eclipse across North America. Priority will be given to programs specifically designed to engage meaningfully in eclipse education, outreach, and science activities with under-represented groups (URGs; including women/girls, ethnic minorities, and people with physical and/or mental disabilities) who often don't imagine themselves in science careers or who believe that science is "not for them."

Jay M. Pasachoff

This program, funded by the U.S. National Science Foundation, is named for the late Jay M. Pasachoff, a member of the AAS Solar Eclipse Task Force and professor of astronomy at Williams College. He studied the heating and dynamics of the Sun's corona at solar eclipses all across the planet and was deeply devoted to advancing astronomy education and science literacy, bringing students on his eclipse expeditions and writing numerous textbooks, trade books, and popular articles.

Number & Size of Mini-Grants

We anticipate making 20 to 30 awards in the standard range \$1,000 to \$5,000 and a smaller number of awards in the augmented range \$5,001 to \$20,000. If you seek one of the augmented mini-grants, you must pay special attention to your budget justification. Legitimate reasons for applying for one of these larger awards include, but are not limited to, the large scale of a proposed program, activity, or event (e.g., the large size of the audience to be reached); the need for expensive equipment to achieve the objective of a proposed science experiment; and the high cost of professional services to be engaged in producing an app, a software product, or a program for radio, TV, or other broadcast. Mini-grants are open to libraries!

Deadline

Proposals are due by 5:00 pm Eastern time on Friday, November 10, 2023.
