# FROM THE DIRECTOR

Here are some updates for the month of April:

State Budget/ Federal Updates — Unfortunately we do not have State budget as I write this today. While NY State is supposed to have a budget in place on April 1, we have seen in recent years that this typically does not occur. The main issues do not appear to be monetary in nature, but instead are about policy issues. There are current indications that a budget may pass in early May and once it is finalized, we will be sharing that information out to you.



The State Library is still at-risk funding wise due to the fact they lost Institute of Museum and Library Services (IMLS) funding. This funding is roughly \$8.1M. The hope is that this \$8.1M will be added into the State budget. The State Library is still uncertain about the status of IMLS and is awaiting word on the lawsuits that have been filed. DLD has pulled back on a few projects that rely on Federal funding but are still moving forward with things that are "mid-stream." The State Library cannot do direct advocacy work themselves, so they are relying on organizations like NYLA, public library systems, and regional library councils to advocate on their behalf. FLLS and our colleagues continue to contact our legislators on this matter.

Just a reminder, FLLS and member libraries are not funded through the federal government. Federal grants and E-rate could be affected.

On a federal level, there are legal responses to the dismantling of IMLS. Letitia James, NYS Attorney General, has joined 20 other states in suing federal government to stop dismantling of IMLS and other agencies. The ACLU and ALA have also filed lawsuits to stop actions against IMLS. We will keep you updated on the progression of these suits.

**Summer Reading Kick-Off Meeting** – On Thursday, April 17, we welcomed library directors and library staff from our member libraries to our building for our annual summer reading kick-off day of learning. Besides our annual meeting, this is our largest in-person event at our system and it was great to see so many of our members join us for our workshop, network with each other, and share ideas for summer reading. The theme for summer reading this year is "Color Our World".

**FLLS Surveys Taking Place** – FLLS is asking our 33 member libraries to take part in a few FLLS surveys. Our first survey is complete and looked at benefits our library staff receive (healthcare, vacation, sick time, etc.). We will be sharing out information on that survey shortly with you. We are currently conducting a survey about accessibility of our physical spaces (our library buildings) and plan to make a brochure for patrons with our outcomes. Our next survey will be about job titles and pay for various library position at our libraries. Look for more information on that survey soon.

# TECH TIP Caution: Smishing!

A <u>smishing (SMS phishing)</u> campaign is targeting iMessage users, attempting to socially engineer them into bypassing Apple's built in phishing protection. For months, iMessage users have been posting <u>examples</u> online of how phishers are trying to get around this protection. And, now, the campaign is gaining traction, according to our friends at <u>BleepingComputer</u>.

It works like this: Under normal circumstances, iMessage will disable all links in messages from unknown senders to protect the user against clicking them by accident. However, if a user replies to a message or adds the sender to their contact list, the links are enabled, allowing the person to click on the link. The text of the messages comes in all the variations that phishers love to use:

- Undeliverable packages from USPS, EVRI, Royal Mail, DHL, Fedex, etc.
- Unpaid road toll.
- Owed shipping fees.
- Other outstanding payments that you are unaware of.

But they all end in a similar way to this:

(Please reply Y, then exit the SMS, re-open the SMS activation link, or copy the link to open in Safari)

Replying with Y (or actually anything) will enable the links and turn off iMessage's built-in phishing protection. Clicking the link will then lead the recipient to whatever malicious website the phisher had in mind. Even if the user just replies with "Y" and then decides not to follow the link—because it looks slightly off—the phishers will know that they have found a likely target for more attacks.

It's also important to know that there are similar instructions for the Chrome browser:

(Reply with 1, exit the SMS message, and reopen the SMS activation link, or copy the link to Google Chrome to open it.)

#### How to avoid smishing scams:

- Never reply to suspicious messages, even if it's only a "Y" or "1." It will tell the phishers they have a live number and they will bombard you with more attempts.
- Never add a number you don't know to your Contacts as that will disable the iMessage protection as well.
- Don't assume any message is the real deal. If you're being asked to do something, contact the
  company directly via a known method you trust. If it turns out to be a fake, you should be able to
  report it to them, there and then.
- If you live somewhere with a Do Not Call list or spam reporting service, make full use of it. Report bogus messages and numbers.
- Your mobile device may already have some form of "safe" message ID enabled without you
  knowing. It's tricky to give specific advice here because of the sheer difference of options
  available on models of phone, but the Options / Safety / Security / Privacy menus are a good
  place to start.
- Check the link before you click it or copy it in your browser. Is it exactly what you would expect it to be? Scammers often use <a href="typosquatting">typosquatting</a> techniques (for example evri[.]top instead of the legitimate evri[.]com, or they fabricate a link that uses the subdomain to make it look legitimate (for example usps.com-track.infoam[.]xyz). If it doesn't look real then don't click on it.
- If a message sounds too good (or bad) to be true, it probably is.

# Applications Are Open for Judith F. Krug Memorial Fund Programming Grants

Deadline: April 30, 2025

Each year the Freedom to Read Foundation (FTRF) distributes grants for organizations to support activities that raise awareness of intellectual freedom and censorship issues during the annual Banned Books Weeks celebration (October 5-11, 2025).

Staff at all types of libraries, schools, universities, and non-profit community organizations are encouraged to apply. Grants are awarded for \$1,000 and applications are accepted now through April 30, 2025.

Grants are evaluated based on the following criteria:

- WHY NOW?: Please share why this grant is important for your organization in this time.
- **IMAGINATION:** What makes your plan unique? Please share how you would integrate the concept of "Read For Your Rights."
- SCHEDULE/ACTION PLAN: Include key dates, responsibilities, and collaboration with other groups to carry out a creative project.
- **PR PLAN:** What are the ways you will promote your event and who is your intended audience? Do you have a media and social media plan? How will your promotion be creative, unique and eye-catching?
- **BUDGET:** Please detail your proposed budget. Institutions, and other groups they are working with should contribute to the funding of proposed events rather than solely relying on the grant. Do not designate all of these grant funds for the purchase of books, or as an honorarium for one speaker.
- **EVALUATION:** Detail how you will evaluate the success of your program.

To be eligible for a grant, organizations must not have been a recipient of an FTRF grant within the past five years. FTRF Founder Judith F. Krug was a fierce proponent of education and intellectual freedom. During Krug's lengthy career she worked non-stop to prevent censorship and protect First Amendment rights.
